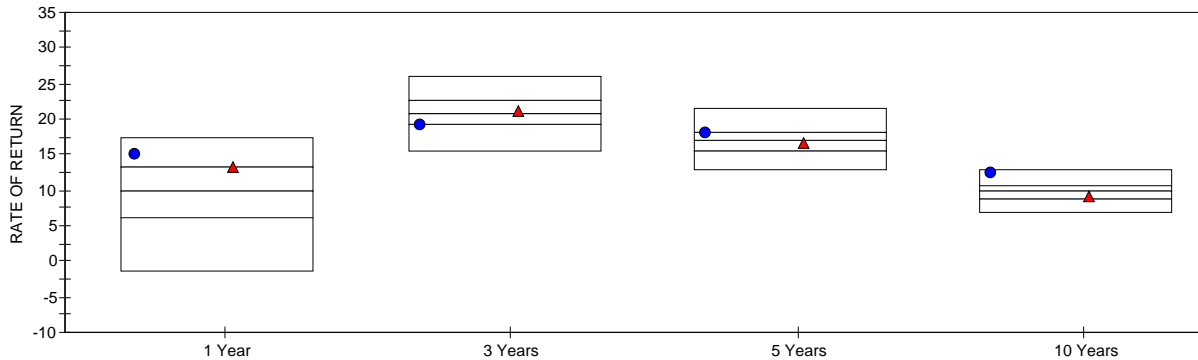

At this point, the top ten performers for the latest 10 year period ending DECEMBER 31, 2014 become the PSN Top Guns Manager of the Decade.
